COMPLAINT

Pennsylvania law expressly preempts the Mayor from banning firearms in public recreational facilities. Nonethless, Mayor Jim Kenney has attempted to do so. He may not.

Pennsylvania law is "crystal clear": regulation of firearms is a matter of statewide concern, and must be undertaken by the General Assembly. *See National Rifle Ass'n v. City of Philadelphia*, 977 A.2d 78, 82 (Pa. Cmwlth. 2009). Mayor James Kenney is not permitted to regulate firarms by executive fiat, as he attempts here.

PARTIES

1. Plaintiff **Gun Owners of America, Inc.** ("GOA") is a California non-stock corporation with its principal place of business at 8001 Forbes Pl., Springfield, Virginia. GOA is orga-

nized and operated as a non-profit membership organization exempt from federal income taxes under the 26 U.S.C. § 501 (c) (4). GOA was incorporated in 1976 to preserve, protect, and defend the Second Amendment rights of gun owners. GOA has thousands of members and supporters, including residents of the City of Philadelphia, who possess Pennsylvania License(s) to Carry Firearms and wish to exercise their right to lawfully possess firearms at recreational facilities.

- 2. Plaintiff **Gun Owners Foundation** ("GOF") is a Virginia non-stock corporation with its principal place of business in Virginia, at 8001 Forbes Place, Springfield, VA 22151. GOF is organized and operated as a nonprofit legal defense and educational foundation that is exempt from federal income taxes under 26 U.S.C. § 501 (c) (3). GOF is supported by gun owners across the country, including Philadelphia residents who are being irreparably harmed by the challenged ordinance. GOF routinely litigates across the country to defend its supporters' right to keep and bear arms.
- 3. Plaintiff Terrence **Ledwell** is an adult individual and resident of Philadelphia. He has a valid Pennsylvania License to Carry Firearms and both has– and intends to– carry in recreational facilities operated by the City of Philadelphia.
- 4. Plaintiff Laura **Leonard-McBride** is an adult individual and resident of Philadelphia. She has a valid Pennsylvania License to Carry Firearms and both has- and intends to- carry in recreational facilities operated by the City of Philadelphia.
- 5. Plaintiff John **Sandefur** is an adult individual and resident of Philadelphia. He has a valid Pennsylvania License to Carry Firearms and both has- and intends to- carry in recreational facilities operated by the City of Philadelphia.

- Defendant City of Philadelphia, is a Municipal Corporation of the First Class of the Commonwealth of Pennsylvania under the First Class City Home Rule Act of April 21st, 1949,
 P.L. 665, § 1 et seq.
- 7. Defendant Mayor James F. Kenney, named in his official capacity as the Mayor of the City of Philadelphia, entered an executive order on September 27th 2022 purporting to ban firearms from city park facilities. Mayor Kenney's principal office is City Hall # 215, Philadelphia, PA 19107.

JURISDICTION & VENUE

- 8. This Court has unlimited original jurisdiction, and venue is proper as the Defendants are a municipality– and public employee acting in their official capacity– within this judicial district. 42 Pa. C.S. § 931, Pa. R.C.P. 1006 (a) and 2103 (b).
- Both the City of Philadelphia and Mayor Kenney are further subject to the personal jurisdiction of this Court, as they are located in – or reside within– the Commonwealth of Pennsylvania.

ALLEGATIONS

- 10. Pennsylvania Law provides "[n]o county, municipality or township may in any manner regulate the lawful ownership, possession, transfer or transportation of firearms" FOAC v. Lower Merion Twp., 151 A.3d 1172, 1176 (Pa. Cmwlth. 2016) (quoting 18 Pa. C.S. § 6120).
- 11. Nonetheless, on September 27th 2022, Mayor Kenney issued an Executive Order # 4-22, which prohibits any person carrying firearms from "enter[ing] or remain in or on any indoor

- or outdoor recreational premises operated by the Department of Parks and Recreation [], including any recreation center, ballfield, court, playground, pool, tot lot, or similar facility, but excluding park trails and passive park space." (Exhibit A).
- 12. Individuals with a valid Pennsylvania License to Carry Firearms are permitted to carry firearms either openly- or concealed- throughout the Commonwealth of Pennsylvania. 18 Pa. C.S. § 6109. The General Assembly expressly provided that a person "licensed to carry a firearm" is permitted to carry "upon any public property in a city of the first class". *Id.* § 6108.
- 13. It is "crystal clear" that only the General Assembly is permitted to regulate firearms. See Nat'l. Rifle Ass'n., 977 A.2d at 82. Further, in 2016, the Commonwealth Court also explicitly struck similar restrictions on carry at public parks due to Pennsylvania's firearms preemption statute. See Lower Merion Twp., 151 A.3d 1172.
- 14. The Mayor's September 27th Executive Order directly regulates the lawful possession of firearms in violation of § 6120 (a).
- 15. Therefore, the September 27th Executive Order violates Pennsylvania's firearms preemption statutes and may not be enforced. *See* 18 Pa. C.S. § 6120.

LEGAL COUNTS

- 16. Plaintiffs incorporates by reference ¶¶ 1–15 above as if fully set forth herein.
- 17. Plaintiffs seek a Declaratory Judgment pursuant to 42 Pa. C.S. §§ 7351 *et seq.* that the Executive Order (# 4-22) signed by Mayor James Kenney on September 27th 2022 is unlawful.
- 18. Section 6120 (a) preempts the City of Philadelphia and Mayor Jim Kenney from regulation of lawful possession of firearms; Executive Order # 4-22 directly regulates the lawful possession of firearms.
- 19. The City of Philadelphia and Mayor Kenney's enactment of the September 27th 2022 Executive Order directly violates Pennsylvania law, and may not be enforced.

RELIEF REQUESTED

WHEREFORE, Plaintiffs ask this Court to find Mayor Jim Kenney's and the City of Philadelphia's September 27th 2022 Executive Order # 4-22 is pre-empted by 18 Pa. C.S. § 6120, and enter a preliminary and permanent injunction against the City of Philadelphia from enforcing any prohibition of firearms at City facilities in violation of Pennsylvania's firearms preemption statute, award costs, and any such other relief as this Court may find just and proper.

CITY OF PHILADELPHIA OFFICE OF THE MAYOR - EXECUTIVE ORDER _____ - 22 DEPARTMENT OF PARKS AND RECREATION – COMMISSIONER'S DIRECTIVE

MANAGEMENT AND OPERATIONAL POLICY PROHIBITING FIREARMS AND OTHER DEADLY WEAPONS AT CITY RECREATION FACILITIES

WHEREAS, the Philadelphia Department of Parks and Recreation (the "Department") has the power and duty to "manage and operate all City recreational facilities" pursuant to Section 5-600 of the Philadelphia Home Rule Charter (the "Charter"); and

WHEREAS, City recreational facilities are owned and operated by the City by and through the Department consistent with its power and duties under the Charter; and

WHEREAS, since 2019, nearly 300 reported incidents of gun violence have occurred at City recreation facilities, in addition to dozens of other incidents of violence with a deadly weapon; and

WHEREAS, most recently Tiffany Fletcher, a Department recreation center employee, was tragically shot and killed on the grounds of Mill Creek Recreation Center on September 9, 2022; and

WHEREAS, approximately 1,700 City employees work on site at recreation facilities, providing critical support to children, families, and our entire Philadelphia Community;

WHEREAS, City recreation facilities are integral to our neighborhood communities: consistently used for after-school activities, sports, and community meetings; reliably offering services from summer camps and digital access to meal distribution, particularly to seniors and school-age children; and dependably available as safe places for all residents of our communities – of every demographic and socio-economic status – to play, learn, relate, and relax together; and

WHEREAS, it is crucial to take steps to assure our City recreation facilities are a safe place for children and all of the Philadelphia community to gather;

WHEREAS, gun violence at City recreational facilities necessitates immediate action; and

WHEREAS, adoption of a policy prohibiting the entry of persons carrying firearms or other deadly weapons on City recreation facilities will increase safety of these facilities for City employees and the public; and

AND NOW, THEREFORE, James F. Kenney, Mayor of the City of Philadelphia, and Kathryn Ott Lovell, Commissioner of the Department of Parks and Recreation, pursuant to all

authority granted under The Philadelphia Home Rule Charter, including but not limited to Sections 1-102, 4-100, and 5-600 thereof; do hereby adopt the following order and directive regarding the management and operation of Department recreation facilities:

- 1. Weapons Prohibited. No one carrying firearms or other deadly weapons is permitted to enter or remain in or on any indoor or outdoor recreation premises operated by the Department of Parks and Recreation (the "Department"), including any recreation center, ballfield, court, playground, pool, tot lot, or similar facility, but excluding park trails and passive park space (collectively "City Recreation Facilities"). This Management and Operational Policy Prohibiting Firearms and Other Deadly Weapons at City Recreation Facilities (this "Policy") shall apply exclusively to the list of City-owned premises attached hereto as Exhibit A. The Commissioner of the Department may designate additional City Recreation Facilities subject to this Policy provided that an up-to-date list of all premises covered by this Policy shall be posted on the Department's publicly accessible website.
- 2. **Signs.** The Commissioner of the Department of Parks and Recreation shall cause signs prohibiting firearms and other deadly weapons to be conspicuously displayed at entrances to all recreation centers and at other prominent locations throughout the City Recreation Facilities subject to this Policy.
- 3. **Exceptions.** Nothing in this Executive Order and Commissioner's Directive shall apply to law enforcement officers; or to trained security personnel acting under contract or supervision of a government agency.

4. Enforcement.

- (a) The safety of recreation staff and of the public shall be of paramount importance. Recreation staff with a reasonable belief that this Policy is being violated shall contact the police. No recreation staff shall take any enforcement action under this Policy without police present.
- (b) With police on the premises, persons reasonably believed to be violating this Policy shall be so informed and asked to leave the premises.
- (c) If a person refuses to leave, the person shall be treated as a trespasser, as provided by law. *See* 18 Pa. C.S. § 3503 (criminal trespass); Phila. Code § 10-615(2)(f) (defiant trespass).
 - 5. Effective Date. This Policy shall be effective immediately.
